5.	For work in III shift from Saturday on Sunday from 22.00h till 06.00h	100%
6.	For work in III shift from day before holiday on holiday	150%

**Notes :**  
 a) Port of Adria may approve a business discount, referring to overtime work, to those ships which have more than five (5) calls during a year.  
 b) Port of Adria reserves the right to sign a special contract on business cooperation, for the category of ships which are of special significance for the Company and City of Bar, in which will be defined amount of fees in the table 1. Decision regarding this issue is made by Administrative authority.  
 c) Shipping company, or its agent, can change a booking of a berth until the start of the season (March). Cancelling booking of berth outside this deadline shall result in additional charge of fee depending on cancellation time as is in Table 3.
